LICENSE TO BE RENEWED ANNUALLY – Title 30-A 3961

The municipal officers of any municipality may grant licenses to persons of good moral character to be pawnbrokers in the municipality for one year, unless sooner revoked by the municipal officers for violation of law.

ACCOUNT OF BUSINESS DONE AND DISCLOSURE TO CONSUMER – Title 30-A 3962

Pawnbroker shall maintain records in which the pawnbroker shall enter the date, duration, amount periodic rate of interest and annual percentage rate, accurate description of the property pawned, terms of redemption or repurchase and the name and residence of the consumer. Additionally, the pawnbroker shall allow the municipal officers to inspect these records at all reasonable times.

MONTHLY REPORTING REQUIRED – Title 30-A 3962 Section 3

Every licensed pawnbroker shall make out and deliver to the China Police or the designee monthly before 4:00 p.m. of the 15th day of each month (or earlier if the 15th falls on a Sunday or holiday), a legible and correct list containing an accurate description of all articles taken in pawn during the preceding calendar month together with the time and date when such articles were pawned.
